Nazzaro Center relocation study draws a large crowd

Once again, it was standing room only at the Nazzaro Community Center on North Bennet Street as residents flocked to the main hall for an update on the relocation of a \$40-\$50 million-dollar new Community Center, which will be managed by the Boston Centers for Youth and Families (BCYF).

BCYF currently manages the Bennet Street site, which will remain open for the construction of the new Center that will be built from the ground up, a first in the City of Boston.

The North End Community Study Committee and several other City of Boston departments presented potential plans calling for the new Center to be relocated to the Mirabella Pool building next to the Coast Guard Base on Commercial Street.

A 40,000-plus square-foot building that will house all the current Nazzaro programs and many new activities will be eventually decided by the neighborhood.

Suggestions by the City included, the move to the Mirabella Pool area, relocating the children's splash pool to an area near the basketball court, removing the diving pool and taking space from the building to make more room for community programs like a full-size basketball court.

Reportedly, a study indicated that the area along the diving pool is not regularly used and it's a safety problem.

Apparently, relocation plans and changes are not cast in stone until plans are approved by the neighborhood.

Study suggestions did not include pickup and drop off for program attendees, one of the things residents made crystal clear that is needed.

It was also made clear by the BCYF that the Nazzaro Center will remain open and active until the relocation project is fully completed and they officially take over the management of the new structure.

However, once the movie

SUPPORT SENATOR MARKEY'S EFFORT TO BAN ROBOCALLS

Robocalls are the new plague of the digital and cell phone era. According to some estimates, Americans received 48 billion robocalls last year, up from 30 billion in 2017. It used to be that only a person's land line would be subject to telemarketers, but these days our wireless phones also are being deluged on a daily basis with these annoying phone calls from robocall centers that typically operate from overseas.

The latest nuance in the robocalling game is spoofing, whereby a robocall essentially hijacks a local phone number, tricking the receiver of the phone call into thinking that the call is coming from someone in one's hometown.

No one is immune from the scourge of pre-recorded robocalls trying to scam us out of our money. And the calls seem to never stop coming. The deluge of these robocalls have become the number one complaint of Americans who have a phone line -- which is to say, just about all of us.

Robocalls have become an epidemic that must be stopped and to that end, U.S. Sen. Ed Markey has introduced a bill, known as the TRACED Act, that will give authorities and the telecom companies the ability to find, catch, and prosecute scammers.

The TRACED Act gives the FCC the authority to levy civil penalties against scammers, extends the window from one to three years to take action against intentional violators, and requires telephone providers to adopt call authentication technologies to verify that incoming calls are legitimate.

This bill already has overwhelming bipartisan support -- one of the few things that Republicans and Democrats can agree upon these days -- and recently passed a Senate committee by a 26-0 margin.

Each of us can show our solidarity behind ending the scourge of robocalls by calling Sen. Markey's office to become a citizen co-sponsor of the TRACED Act.

Let our elected officials know that the sooner Congress takes action, the better.

WILL APRIL SHOWERS BRING MAY FLOWERS?

As Bob Dylan noted, 'you don't need a weatherman to tell you which way the wind is blowing'. Similarly, we have not needed a weatherman to tell us that this has been a particularly rainy April.

However, we learned this week just how rainy it has been with the news that this April has set the record for the most days with rain. The previous record had been 19 days, set in 1912. However, as this is being written, we are poised to attain a new mark of 21 days with rain.

We hasten to point out that this has not been the wettest April. Although total rainfall is more than three inches above normal for the month, it still is well below a record-setting total.

Yes, the mild temperatures have been nice -- this April reportedly is in the top 10 for warmest-ever -- but with all of that the wind and rain, especially coming off the ocean, we have not been able to enjoy the warmth as much as we would have liked.

Hopefully, the old song about April showers bringing May flowers will be predictive of the month ahead. So we thought it would be appropriate to publish a verse from that old song, which has been around since the 1920s:

Fighting the opioid epidemic with care and data

A little more than a year ago, I had the opportunity to visit Maryhaven treatment facility in Columbus, Ohio, to hear from those recovering from the effects of addiction. The visit was an impactful one. I met with individuals who talked about the terrible impact addiction had on their families. I heard from employers looking to offer a second chance to those in need. I heard from both about the importance of job skills and having a job in recovery.

With National [prescription] Take Back Day this week, the Department of Labor released new information on what we have learned about the opioid crisis and how we are improving our effectiveness in overcoming its challenges.

In 2017, President Donald Trump's administration declared the opioid epidemic a national public health emergency and directed all executive agencies to use every appropriate emergency authority to minimize the devastation. Since 2017, the U.S. Department of Labor's Office of Workers' Compensation Programs' (OWCP) has dedicated

significant resources to stem the abuse, misuse, and proliferation of opioids to protect 2.7 million federal workers from harmful opioid prescription practices.

The use of opioids to treat injured federal workers continued, virtually unchecked, until 2017. The capability to monitor dose level and duration by the department was not even available until operational changes were instituted that year. Since we started this effort, a series of successes can be attributed to the implementation of a four-point

strategic plan: (1) effective controls, (2) tailored treatment, (3) impactful communications with employees and providers, and (4) aggressive fraud detection.

The strategic plan's core is a process where the department continuously gathers information and analyzes data. The results yielded great progress:

- 51 percent decline in new opioid prescriptions that last more than 30 days;
- 59 percent decline in claim-

NAZZARO CENTER RELOCATION HAS PROS AND CONS

Recommended plans for the relocation of the Nazzaro Community Center to the Mirabella Pool site has its pros and cons but overall with some changes it appears to be a positive site if community concerns are addressed.

The \$40-50-million construction project is the first community center that will be built from the ground up. The project will take about two years with the current center

continuing to operate as usual until the new center is completed and in use.

Once that occurs, the 100-year-old building will become surplus and that's a horse of a different color and a totally new process comes into play with Requests for Proposals (RFP) to determine the occupancy of the building.

Fortunately, the City has agreed to meet with residents before the RFP is to address the request that a senior center remains in the building on North Bennet Street.

This is possible if a non-profit organization is selected through the RFP system. There is still some kind of hope to accomplish this, but it will require a major community endeavor that will require the full support

of the neighborhood's elected officials.

NEWRA RELEASE TOTALLY MISLEADING

The North End/Waterfront Neighborhood Residents' Association (NEWRA) through emails continuously refers to the Nazzaro Community Center as a historic site, it is not!

NEWRA also refers to the building as an historic site as well. It is not. An attempt to make the perimeter of the Bath House a landmark is in the making but it has not happened at this time.

This is totally misleading! NEWRA fully knows neither sites are historic, so why do they continue to confuse the issue?

takes place, the Bath House building will become surplus and BCYF will no longer manage the building and will have no say as to what happens to the 100-plus-year-old facility.

In addition, once declared surplus, that's a horse of different color and the City of Boston will create Request for Proposal (RFP) to determine the faith the building.

The neighborhood will play a role in the RFP requirements before it goes out to the public for potential development, according to the City.

As far as the relocation site, residents did not like the placement of the splashing pool or the removal of the diving pool which they claim is well used by teens and young adults.

They disputed the claim by the City that the area is not well used and the removal will create the loss of seating and surrounding area.

Regarding the splashing pool, it was a suggestion to move it to DiFilippo Playground (Gassy). They did not like the relocation site proposed.

There was no drop off or pick-up area included in the current plans and residents were concerned.

One suggestion was to relocate to the Fulton Street site next to the expressway, which is being used by the City for parking. Vehicle pollution was a prime issue at the site.

Residents wanted the Center to remain open even with a new site. They called for a senior citizen program to remain active and for public meetings space.

They noted that getting to and from the Commercial Street site was too far for seniors and crossing a major street to get to the site was dangerous.

They asked for the City to set up a neighborhood meeting before any RFP would be issued to make sure that there was direct input from the neighborhood. The City agreed.

Residents were told that the best possible way this could occur is if a non-profit organization manages to take over the property.

The community was assured that there are no plans to build condominiums in the old building and at this time there was no funding allocated for new neighborhood Center.

Residents told the City they didn't like the relocation of the children's splash pool, the removal of the diving pool and a lounging area that will be lost.

One community suggestion was to the pool to the DeFilippo Playground on Prince Street.

All suggestions by the community will be taken into consideration and another public meeting could be scheduled.

The wharf site apparently has a sea-water level potential problem and Fulton Street has a possible vehicle emission problem due to its closeness to the expressway and the mouth of the tunnel.

ants prescribed a morphine equivalent dose (MED) of 500 or more:

- 31 percent decline in claimants prescribed a MED of 90 or more:
- 30 percent decline in overall opioid use; and
- 24 percent drop in new opioid prescriptions

A recent study highlights the unique challenges facing a legacy population of injured federal workers who have been prescribed opioids over an extended period of time. Specifically, the study showed that nearly 1 in 4 injured workers in this group had been prescribed a high dose of 90+ morphine equivalent dose. This is important because the higher the opioid dose, the higher the risk for misuse and overdose death. Higher doses, greater than 100 MED, have more than two times the risk relative to lower doses. Additional risk factors, including the use of extended-release opioids and the associated use of certain interacting medications, were also identified.

The legacy challenges needed to be confronted. All federal injured workers with a prescription of 90+ MED underwent extensive individual case reviews. Treating physicians were contacted and, as needed, nurses were assigned. Our goal was to work with the medical provider and injured worker to provide opioid treatment where needed, reduce the opioid risk level, and assist in securing the Tapering an addictive drug takes time and there are a host of interacting factors to consider, yet as the statistics

prove, the intense focus produced a real difference. This effort is not the federal government deciding what is best for patients. Rather, the federal government is acting as a responsible employer by caring about its workforce and ensuring that employees are getting the treatment and support needed for what can be a challenging recovery.

We are committed to (1) engaging individual employees and (2) analyzing the effects on

the employee population as a whole. To win this battle, we must embrace a strategy that pursues accurate information, continuously evaluates that information, and invests the time necessary to find the right, healthy solutions for individuals struggling with opioids.

BOARD OF APPEALS APPROVES 2 SNELLING PLACE PROPOSAL

Despite overwhelming opposition by abutters, the North End Waterfront Neighborhood Council (NEWNC) and the North End Waterfront Residents' Association (NEWRA), the City of Boston Board of Appeals gave the go-ahead to the 2 Snelling Place proposal.

The Board's decision was unexpected by residents who question the final outcome.

Plans call for a one-story addition, expanding living space in the basement and a private roof deck.

Joe Giangregorio proposes to place retail space on the ground floor, nine residential units and a roof deck on the new structure.

North End Liaison Maria Lanza is helping to coordinate the Coffee Hour and will also be available to speak with residents.




In addition, each family in attendance will receive a flowering plant growing in the City's green house as a gift from the Mayor.



John and Steven wished everyone and to enjoy the spring and summer. "We'll see you next year for another exciting basketball season," they commented.





MUNICIPAL LOBBYIST REQUIRED TO REGISTER WITH CITY

A registration portal for lobbyists in Boston has been launched by the City requiring registration twice a year.

In 2018, Mayor Martin Walsh signed into law the City's municipal lobbying ordinance aim to further promote good government, requiring lobbyist, lobbyist entities and lobbying clients to register with the City Clerk Office.

There will also be two different disclosure statements reporting requirements due on or before July 20 and October

20.

The City Council, after years of negotiations with the Mayor and his Administration passed an ordinance creating a system that brings accountability to municipal lobbying for the first time according to the Mayor.

"This ordinance will help to meet the high expectations that Boston residents expect and deserve," Mayor Walsh said.

The ordinance also created a City-level enforcement commission to ensure compliance.
