## North End bank robbery suspect caught

The Boston man wanted in connection with a September bank robbery in the North End has been apprehended.

Just before 9:30 am on Sunday, December 19 Boston Police arrested Rolando Gala, 39, of Boston. Gala was wanted on an outstanding warrant issued out of Boston Municipal Court for Unarmed Robbery and was arraigned in Boston Municipal Court.

The incident occurred just after 9 am on Friday, September 17,

when officers assigned to District A-1 responded to a call for a bank robbery on Hanover Street in the North End.

After an investigation police detectives identified Gala as the possible suspect in the robbery. Police obtained an arrest warrant out of Boston Municipal Court for Gala on Unarmed Bank Robbery

Detectives assigned to District A-1 (Downtown) and the Violent Crime Task Force continue to review the facts and circumstances surrounding this incident and are urging anyone with information relative to this investigation or knowledge of the suspect's current whereabouts to contact (617) 343-4248.

The Boston Police Department will stringently guard and protect the identities of all those who wish to assist this investigation in an anonymous manner.

# Up for Grabs

After Edwards wins the Special Election for State Senate; a field of candidates begins to emerge for District Councilor

District 1 City Councilor Lydia Edward's impressive victory over Revere's Anthony D'Ambrosio last week for the First Suffolk & Middlesex State Senate seat will spark a Special Election for her district council seat after the formality of a January 11 General Election.

With no Republican on the January 11 ballot Edwards will be heading from City Hall to Beacon Hill and her council seat, which includes the North End, East Boston and Charlestown, will be up for grabs.

Already, the city's director of the Mayor's Office of Women's Advancement Tania Del Rio has announced her intentions to run for the seat.

Del Rio, of East Boston, said she was 'all in' and has already launched an online fundraising effort for her campaign.

Before being appointed to the Office of Women's Advancement by former Mayor Martin Walsh, Del Rio served as the City of

Boston's Diversity Outreach Officer, where her work is focused on helping the City of Boston shape a workforce that is reflective of its population, and promoting diversity and inclusion among Boston's employers. Before joining the City of Boston she served as the head of the Citizen Protection and Community Affairs Departments at the Consulate of Mexico in Boston, and the head of Political Affairs and Press at the Embassy of Mexico in Colombia.

Del Rio earned a bachelor's degree in international relations from New York University and a masters in public policy from Harvard Kennedy School of Government. Del Rio was recognized by the Harvard Kennedy School with the Jane Mansbridge Research Award for distinguished research related to gender and public policy and the 2016 Outstanding Policy Analysis Exercise Award, for her paper on gender equality in the Foreign Service.

# EDITORIAL

#### HAVE A MERRY -- AND SAFE --CHRISTMAS

The holiday season usually is the most wonderful time of the year.

But Christmas, 2021, is anything but wonderful, even for those of us who are among the most fortunate in our society.

Our collective stress and anxiety levels are at an all-time high thanks to the recent arrival of the Omicron variant of COVID-19, which has upended the holiday plans for many of us.

Each and every day, the virus is killing almost 1300 Americans, a statistic that has become mind-numbingly routine. That figure still is well below the 3000 deaths per day a year ago at this time, but still, it translates into 500,000 deaths per year.

Hospitals once again are at full capacity in many states, with coronavirus patients filling emergency rooms and crowding-out those who have other health issues.

This was not the scenario we had envisioned a few months ago, when it appeared that we had COVID-19 under control.

For those of us who are fully-vaccinated with three shots of the Moderna or Pfizer vaccines (or one J&J plus one of the those other two), the effects of the Omicron variant are proving to be fairly mild, akin to having a bad cold.

But for anyone who is unvaccinated, infection with the Omicron variant is proving inescapable thanks to its high-degree of transmissibility. And as the statistics demonstrate, the chances of becoming seriously ill are dangerously-significant.

Although the pandemic has eviscerated the usual holiday celebrations that bring together family, friends, and colleagues, adding to our mental health issues, especially for older Americans, the toned-down holiday season offers us an opportunity for reflection, a chance to reach an appreciation for the things that really matter in our lives: The health and safety of ourselves and our loved ones, as well as the urgent need to assist those who find themselves in dire straits this holiday season.

We hope that all of our readers will heed the warnings of our public health officials and that those with the means to do so will help the vast numbers of our less-fortunate fellow Americans.

We wish all of our readers a merry -- and safe -- Christmas.

### ABCD reaches 6,000 toy goal for holiday drive

'Twas three weeks before Christmas and...

The ABCD toy room was rather empty. About 400 toys rested on the distribution tables. Meanwhile requests for help were pouring in at an unprecedented rate. 6,000 toys were needed for families seeking to celebrate Christmas, Kwanzaa, Channukah and Three Kings Day.

"With the pandemic still impacting the families we serve in Boston and the Mystic Valley region – with jobs lost and soaring prices – many parents had very limited resources for buying gifts for their children this year," said ABCD President/CEO John J. Locally, Del Rio is a member of the Board of Directors of the Veronica Robles Cultural Center; Partakers Inc., and Excel Academy, and contributes monthly as a columnist in El Heraldo Latino Newspaper. Del Rio was born in Mexico City and raised as a bicultural child between the U.S. and Mexico. In addition to her native Spanish, she can also speak French and Italian.

Former Edward's Chief of Staff and lifelong Eastie resident, Gabriela Coletta is also mulling a run for her former boss's seat.

Coletta, who left Edward's office over the summer to become the External Relations Manager for the New England Aquarium's downtown waterfront planning initiative, first joined Edwards in 2017 as her campaign manager for the Boston City Council seat and also worked on the campaigns for Rep. Adrian Madaro and interned Rep. Aaron Michlewitz.

"Thank you, for everything, Boston City Councilor Lydia Edwards," said Coletta last week in a statement after Edward's win. "I'm so grateful to have had the opportunity to serve the district as your Chief and to have had a seat at the table witnessing your fearless advocacy. The fight continues for housing justice, environmental justice, and tackling education inequities. I'm taking time to talk to family and friends to consider if this is the best opportunity to serve the district I'm so proud to call my

home. Thank you to everyone who has reached out so far. I'll have more to say soon."

Coletta graduated from Boston Latin Academy and went on to graduate from UMass Boston before beginning her career in public service.

Eastie resident Jason Ruggiero, who has spearheaded the PLAN: East Boston initiative for the Boston Planning and Development, is also considering a run for the seat.

Like Coletta, Ruggiero congratulated Edwards on her victory last week saying, "I've had the privilege to see first-hand up close and personal the work that Lydia has done as the Boston City Councilor for District One, representing East Boston, Charlestown and the North End. As someone who also represents these communities at an Agency level within the City of Boston, I applaud and thank Lydia for all she has done for these communities."

Ruggiero added that while Edward's work and advocacy will transition to the State House, over the next few weeks he will be considering a candidacy to attempt to fill her "tremendous shoes" at City Hall.

"Our next City Councilor needs to put our community and the people first, be creative in how to address the complex challenges before us today, and fight for everyone with the urgency and dedication Lydia has shown over the last four years," he said. "The diversity of our district is its beauty, and our unity in advocacy and representation is its strength. There is no more urgent time than now to ensure we have dedicated public servants representing our communities on the elected level. East Boston, Charlestown, the North End, I look forward to talking to you more soon."

The North End's Stephen Passacantilli, who ran an unsuccessful bid against Edwards for the District 1 seat back in 2017 is rumored to be considering another shot at the seat. Passacantilli signaled last week that he'd be a 'fool' to not consider another run but would discuss it with his family before making any decisions.


Eastie's Andreas Castillo, a lead organizer for City Life/Vida Urbana, is also planning a run for the seat. Castillo has dedicated his career to fighting gentrification and displacement in Boston through his work with City Life.

Catillo holds a degree in Political Science and Government from Suffolk University.

There were some rumors that former District 1 City Councilor Sal LaMattina may come out of retirement to once again serve the people of Eastie, the North End and Charlestown but in a statement to the media LaMattina said, "While the prospect of working again on behalf of the people of Boston would be exciting and rewarding I have learned to value my retirement and enjoy the time I can spend with

family and friends. Therefore, after careful consideration, I will not be a candidate for the District 1 City Council seat. Moreover, I look

forward to providing support and guidance to whomever is elected to succeed my friend, Senator-elect Lydia Edwards."

# North End, surrounding area's weekly COVID infections increase

With the Omicron COVID variant now the most prevalent variant sweeping across the US-making up nearly 75 percent of all new cases—the North End and the surrounding areas's weekly COVID positive test rate rose once again ahead of the Christmas Holiday.

With COVID infections spreading like wildfire Boston Mayor Michelle Wu announced Monday a new initiative to require vaccination in certain indoor spaces in the city, including indoor dining, fitness, and entertainment establishments. The new "B Together" initiative will begin January 15 and will phase in second vaccine doses and youth vaccination requirements. Both patrons and employees of indoor venues will be required to show proof of vaccination and the indoor mask mandate remains in effect.

"Vaccines are the most powerful tool we have to fight this pandemic. Vaccination saves lives, and closing vaccination gaps is the best way to support and protect our communities, businesses, and cultural institutions during this pandemic," said Mayor Wu at a City Hall press conference Monday. "The vast majority of COVID-related hospitalizations are of unvaccinated individuals, which is impacting our entire healthcare system and compromising the health of our communities. Today's steps to protect community members in certain indoor establishments and throughout our city workforce will help ensure that everyone in Boston will be safe. City government must take down barriers and direct our resources for easy access to testing and vaccination to protect our city and all of our communities."

According to the weekly report released Monday by the Boston Public Health Commission (BPHC), 2,693 North End, Beacon Hill, Back Bay, West End and Downtown residents were tested and 6.2 percent were positive. This was a 29 percent increase from the 4.8 percent that tested positive between December 6 and December 13. The weekly positive test rate is up 100 percent in the area since December 6.

However, the citywide weekly positive test rate remained the same last week. According to the BPHC 30,754 residents were tested and 6.7 percent were COVID

positive--this was the same percentage reported by the BPHC on December 13.

In all, 167 additional residents have been infected with the virus between December 13 and December 20 and the total number of cases in the area increased to 4,846 cases overall since the pandemic began.

"COVID-19 cases and hospitalizations are on the rise in Boston. The B Together initiative is just one component of a multilayered, comprehensive strategy that the city has implemented to address COVID-19 and promote the health and safety of Boston residents," said Executive Director of the Boston Public Health Commission Dr. Bisola Ojikutu. "We must also ensure that every Bostonian has easier access to vaccines and boosters, and we will be rolling out new sites across the city."

Starting January 15, 2022 patrons of covered businesses will be required to show proof of vaccination upon entering the premises. The order states that individuals can demonstrate vaccination by showing their CDC vaccination card or a photo of their card, any official immunization record or digital image from a pharmacy or health care provider, or on any COVID-19 vaccine verification app. The city also announced plans to create its own app, modeled on the successful Key to NYC app that has supported the vaccine requirement effort in New York

Businesses included will also be required to post a notice at all entrances. The city will begin a weeks-long campaign to educate residents and businesses about the new policy, utilizing city outreach workers and inspectional services. Businesses found not in compliance will receive verbal and written warnings. Repeat offenders may be subject to fines.

The statistics released by the BPHC as part of its weekly COVID19 report breaks down the number of cases and infection rates in each neighborhood. It also breaks down the number of cases by age, gender and race.

Citywide positive cases of coronavirus increased 4 percent last week and went from 92,170 cases to 95,790 confirmed cases in a week. There were 15 additional deaths in Boston from the virus in the past week and the total COVID deaths is now at 1,493.



### Leftover safety: Extending your holiday meals

Enjoying terrific food is one of the highlights of the holiday season. However, all good things must come to an end, including the holiday celebrations. But holiday meals often bring leftovers and leftovers can help stretch out your holiday cheer. According to Mystic Valley Elder Services Registered Dietician Candace Quigley, it's important to assess the safety of the foods that are leftover. "If perishable foods, such as meat, poultry, cooked foods, cheese, cut up fruits and vegetables, were out for more than two hours, they should be discarded," she says. "The last thing your winter season needs is a bellyacheor worse—caused by improperly stored leftovers. And after the holidays, you may find yourself with a particularly full refrigerator."

To keep your food tasty and free of nasty bacteria, follow these food safety tips (adapted from the Federal Food Safety Service):

Keep food out of the danger zone: Bacteria grow rapidly between the temperatures of 41° F and 140° F. After food is safely cooked, hot food must be kept hot at 140° F or warmer to prevent bacterial growth. Make sure to refrigerate the food within 2 hours of cooking food or after it is removed from an appliance keeping it warm.

Cool food rapidly: To prevent bacterial growth, it's important to divide large amounts of hot food into shallow containers so it reaches the safe refrigerator-storage temperature of 41°F or below as fast as possible. Cut large items of food into smaller portions to cool. Cut turkey into smaller pieces and refrigerate. Store turkey and stuffing in separate containers.

Wrap leftovers well: Cover leftovers, wrap them in airtight packaging, or seal them in storage containers. These practices help keep bacteria out, retain moisture, and prevent leftovers from picking up odors from other food in the refrigerator. Immediately refrigerate or freeze the wrapped leftovers for rapid cooling.

Store leftovers safely: Leftovers can be kept in the refrigerator for 3 to 4 days (gravy should be used within 1-2 days) or frozen for 3 to 4 months. Consider marking your leftovers with the date.

Reheat leftovers safely: When reheating leftovers, be sure they reach 165° F as measured with a food thermometer. Reheat gravy, sauces, and soups by bringing them to a rolling boil. When reheating in the microwave, cover and rotate the food for even heating. Arrange food items evenly in a covered microwave safe glass or ceramic dish, and add some liquid if needed. Be sure the covering is microwave safe, and vent the lid or wrap to let the steam escape. The moist heat that is created will help destroy harmful bacteria and will ensure uniform cooking.



tion are anticipated to be higher than normal. Drivers and public transportation ridership customers should use available real-time tools and resources for current travel conditions on major roadways such as dialing 511, visitingwww. mass511.com or using the GoTime mobile app, and check MBTA

schedule information available at mbta.com/holidays and the weather forecast before leaving home.

"During this holiday season, we are reminding drivers to expect more people traveling by car, public transportation, and in airports and to plan for any trips by checking conditions ahead of time

and building in extra time," said Transportation Secretary and CEO Jamey Tesler. "Make sure to drive sober and hands free, follow speed limits, and be patient as more people return to traveling this season."

The Highway Division is taking several steps to ensure safe and efficient travel on state-owned roadways. There will be no construction work on major arterial roadways from 5:00 a.m. on Friday, December 24, 2021, through the normal start of business at 5:00 a.m. on Monday, December 27, 2021, and from 5:00 a.m. on Thursday, December 30, 2021, through 5:00 a.m. on Monday, January 3, 2022.

In addition, the High Occupancy Vehicle (HOV) lane located on I-93 between Boston and Quincy will extend its afternoon hours by opening from 2:00 p.m. to 7:00 p.m. on Thursday, December 23. 2021, and on Thursday, December 30, 2021. The HOV lane will be closed on Friday, December 24, 2021, and on Friday, December 31, 2021. Also, due to increased travel in and out of Logan Airport, the Sumner Tunnel swing lane will not be deployed on Friday, December 24, 2021, and Friday, December 31, 2021.
