City, LIHC Investment Group, Belveron Partners work to preserve affordable housing in the North End

Even before the COVID-19 pandemic hit Boston was facing a housing crisis. Rising property values and rent have forced many longtime Bostonionas to seek housing elsewhere, sometimes miles from the city they called home for decades.

The pandemic has not helped the situation and more and more residents are facing housing insecurity as job loss and a weakening economy have threatened the stability of many.

Luckily there is some hope on the horizon for North End residents living at Mercantile Wharf in the North End.

On Wednesday, Mayor Marty Walsh announced, together with LIHC Investment Group, Belveron Partners, and the Boston Housing Authority, the preservation of 60 affordable rental homes at Mercantile Wharf with the support of the building's tenants.

Columbus Statue to get a new home

The North End's Christopher Columbus statue, that was vandalized once again over the summer during protests in Boston, will not return to its pedestal in Christopher Columbus Park according to Mayor Martin Walsh.

Instead, the Boston Arts Commission will begin a process to design and construct a new statue honoring Italian immigration to Boston at the waterfront park.

The damaged statue, which is currently being restored, will most

likely end up at the senior housing development currently under construction in the neighborhood on North Margin Street.

Mayor Walsh made the announcement Monday during a virtual ZOOM meeting with the North End/ Waterfront Neighborhood (NEWNC).

"The Columbus statue, I means an awful lot to residents of the North End and obviously it's a very passionate, emotional issue,

said Walsh during the meeting.

The Mayor pledged to create an advisory group of North End residents that will work with the Boston Arts Commission on designing the new statue honoring Italian Immigrants. He also said there will be a "'robust community process" as the city and residents move forward on what sort of statute should commemorate the history of Italaians in Boston.

The Boston Art Commission will hold its next meeting on Tuesday, October 13 at 4 p.m, just one day after North Enders will celebrate Columbus Day, and begin a preliminary discussion about the new plan.

In recent years the Christopher Columbus statue in the park has been the subject of vandalism, with some calling for its removal due to his alleged hand in indigenous genecoide in the Americas.

However, during the racial unrest that has swept across the nation in June, the Columbus statue was again vandalized.

First, red paint was thrown at the statue and Black Lives Matter spray painted at the base. Then a few days later the statue was decapitated.

The statue was removed by the City of Boston and is being stored in a warehouse by the city to be restored.

Once restored there is a tentative plan to place the Columbus statue at the former Knights of Columbus building on North Margin Street that is currently being redeveloped into 23 affordable apartments for seniors.

When Christopher Columbus Park was dedicated by Mayor Kevin White in the 1970s as one of the earliest waterfront parks in Boston, the true history of Columbus's atrocities against indegenoius people wasn't common knowledge...

In schools across the country and in the North End, it was taught tat Columbus was an important explorer that discovered the New World aboard his three ships. He became hero to Italian Americans everywhere.

The Columbus's legacy continues to be debated and while he was widely venerated in the centuries after his death, public perceptions have changed as scholars have given greater attention to negative aspects of his life.

Historians now widely agree of his role in enslavement of the indigenous population in his quest for gold and his brutal subjugation of the Taíno people of Hispaniola, leading to their near-extinction.

While Columbus has a complex history and symbolizes many different things to different people, there is a lot more to the history of the park than just the naming of it.

The park was built in the late 1960s/early 1970s under Mayor Kevin White and designed by his Parks Director Tony Forgione. It was advocated by the North End residents, who were watching their entire waterfront turn into development. The statue was placed later on as a celebration of Italian heritage and was paid for by the families that surround the base of the statue. Some of those families were original North End immigrant families.

Groups that have met with Mayor Walsh so far to discuss the future of the statue are the Sons and Daughters of Italy, UNICO, Foundation of Italian Organizations, St. Joseph's Society, Pirandello Lyceum and the Italian American Alliance.

EXPANDED FUNDS FOR RESTAURANTS

More innovative work was completed to improve atmosphere in the space with lighting as a way to bolster the color temperature of private classrooms.

In addition, acoustic paneling was adorned in bold bright colored fabric to create energy and enthusiasm into practice rooms.

Significant investments were made in the Prado site office equipment, studio furniture and instrument inventory.

NEMPAC Executive Director Sherry Snow said, "We invested in this equipment for the purpose of


Alyssa has found herself becoming more involved in the community while working as a reporter for a local North End new site.



Something needs to be done about evictions

Hundreds of thousands of Massachusetts residents are at risk of displacement and homelessness if evictions are allowed to continue unabated without any protections from the legislature. Massachusetts has deployed various strategies to mitigate the harms from the COVID-19 pandemic, but its most effective strategy, a state-wide moratorium on housing evictions, is set to expire on October 17. Last week, Governor Charlie Baker announced his unwillingness to extend the moratorium; in doing so, the Governor removed the crutch keeping the system upright. With evictions set to resume, the housing crisis that loomed over the state is now here. The next great public health crisis has arrived, and Massachusetts is unprepared.

Recent predictions suggest that 21 percent of renter-households in Massachusetts, representing close to half a million people, could be at risk of eviction by the end of the year. Employment disruptions and lost income due to the pandemic have stymied renters' ability to keep up on payments. According to tabulations of the Census Bureau's Household Pulse Survey, 15 percent of Massachusetts renters, representing 348,000 people in 151,000 households, were

behind on rent. Notably, due to

persistent housing discrimination, Black and Latinx households are disproportionately affected.

An avalanche of evictions will overwhelm our legal system. The Boston Bar Association reported in 2019 that tenants are unrepresented in 91.3 percent of eviction cases. Anecdotally, at the Harvard Legal Aid Bureau, the second largest legal aid provider in Boston, we only have the capacity for about 60 individual housing cases at once. As a result, the bulk of tenants facing eviction will be forced to represent themselves. The inequities of this arrangement become blindly apparent when pro-se defendants are forced to litigate against institutional landlord lawyers.

Further, housing courts will be expected to juggle an unprecedented amount of cases in unprecedented circumstances after the moratorium expires. Considering valid safety concerns, housing courts will need to rely on virtual hearings and trials at the expense of low-income tenants that may not have the requisite technology. The issues highlighted raise due process concerns, a core principle of our legal system, and likely will lead to miscarriages of housing justice.

Housing is a human right, but when we tolerate anything less there are societal consequences. Housing instability increases public costs. For example, a 2018 study found that unstable housing among families with children will cost the U.S. \$111 billion in avoidable health and education expenditures over the next 10 years. Housing instability is deeply intertwined with many social, economic, and health issues. It negatively affects an individual's ability to maintain a job, acquire a quality education, or routinely secure food. Housing instability leads to overcrowding and homelessness.

Overcrowded housing is closely-related to elevated COVID-19 rates in communities. Homelessness is not only a moral tragedy, but also impacts the availability of healthcare resources, magnifies a community's reliance on police, and harms business and tourist attractions, particularly downtown. If we do nothing in this moment, we negligently contribute to our country's housing injustice.

For all these reasons, the Commonwealth needs to pass the Housing Stability Act. The Housing Stability Act – Bill H.4874 – offers a systemic solution to prevent the ensuing flood of evictions. The Act guarantees housing stability during the COVID-19 crisis by banning evictions due to nonpayment of rent for any tenant

Walsh said the move is building on his commitment to creating and maintaining affordable housing in the City of Boston, especially during these very difficult times.

"Preserving affordability in housing is a top priority for my administration, and I am so proud that with the support of many partners involved we have been able to secure long-term housing affordability for tenants at Mercantile Wharf," said Mayor Walsh. "I want to thank everyone involved for their support and assistance in keeping these units affordable for residents in the North End."

According to the city, Mercantile Wharf is a 122 unit mixed-income community that received subsidies through the 13A mortgage program in the 1970s, which allowed property owners to secure low-interest loans in exchange for providing below-market rents to tenants.

In 2018, the provisions governing Mercantile Wharf expired, putting it at-risk of losing its affordability as units became vacant and re-rented at market rate.

Instead of allowing this to happen, owners LIHC Investment Group and Belveron Partners have agreed to a preservation plan with the Boston Housing Authority and MassHousing to protect existing residents and maintain the units for low-income tenants in the future.

Under the terms of the agreement, 48 very low-income households at Mercantile Wharf were eligible for and will benefit from a new Project-Based Section 8 contract, guaranteeing their homes will remain affordable for at least the next 20 years. These federally backed, project-based vouchers are a form of rental assistance that stays with the property so if a unit becomes vacant, it is reserved for

incoming tenants earning no more than 50 percent AMI. Section 8 also limits the amount a tenant pays toward rent to 30 percent of their adjusted gross income.

Ten low-income house-holds-those with incomes between 51 percent and 80 percent AMI-will receive tenant-based rental assistance from the Massachusetts Rental Voucher Program (MRVP), in addition to two more house-holds that opted into the mobile MRVP program. Households with mobile MRVP vouchers will pay approximately 40 percent of adjusted gross income towards rent

"This agreement ensures that longtime residents of Mercantile Wharf will continue to remain in their homes and that affordability protections remain in place for decades," said MassHousing Executive Director Chrystal Kornegay. "MassHousing's top priority in addressing expiring Section 13A mortgage restrictions is ensuring that at-risk residents are protected, and we thank the City of Boston for its leadership in preserving this important affordable housing resource."

BHA Administrator Kate Bennett said this was an agreement that will ensure housing stability for dozens of families in the North End.

"Communities like Mercantile Wharf are an essential part of the city's urban fabric, and we are proud of the role we've played in securing their long-term future here in Boston," she said.

Charlie Gendron, Principal, LIHC Investment Group explained that rising rents in this part of Boston have forced many longtime residents to move elsewhere, however that will not be the case at Mercantile Wharf. LIHC Investment Group has partnered with the City of Boston on several occasions in the past to preserve at-risk properties, including 171 homes at Concord Houses in the South End.

"Prioritizing the preservation of communities like Mercantile is an effective way of maintaining the mixed-income, diverse neighborhoods which made Boston the great city that it is today," said Gendron. "We wish to thank Mayor Walsh, DND, BHA, and MassHousing for working hand-in-hand to make this preservation possible, as well as our residents and MAHT for their patience, support, and for helping get us across the finish line."

President of Mercantile Wharf Tenants' Association Sandi Padellaro said the tenants are thrilled about the outcome. Padellaro and the Association helped spearhead negotiations with the owners and city agencies

"Not only will 60 affordable apartments be saved for our Mercantile Wharf community, but most tenants will actually win a rent reduction," said Padellaro, . "Ours is the only building in this zip code that offers any affordable housing and its preservation is critical to the stability and future of our beloved neighborhood. We want to thank the Mass Alliance of HUD Tenants (MAHT) for helping us organize and partner with the owners to propose creative solutions that helped save our home."

Padellaro also applauded LIHC and Charlie Gendron for their flexibility and willingness to help the tenants achieve their vision of an affordable, mixed-income community in a prime location on Boston's North End Waterfront.





unable to pay directly or indirectly because of the COVID-19 crisis. The eviction ban covers rent due at the start of the COVID-19 state of emergency through 12 months after the state of emergency has ended. The Act also protects homeowners and small landlords by banning foreclosures due to missed mortgage payments throughout the same period.

Finally, the Act establishes an Oversight and Advisory Board of members from the hardest hit communities to make recommendations on how the COVID-19 Housing Stability and Recovery fund is administered.

The positive effects of the Housing Stability Act are obvious: more protections for tenants and homeowners; less homelessness for adults and children; finally, less pain and despair in the Commonwealth. The novel coronavirus has upended our way of life. But we should not let it uproot folks from their homes. To stop the imminent housing crisis, please act by calling your legislator in the Massachusetts State House and urge them to vote yes for Bill H.4878.

COVID-19 Update for North End; Boston enters 'red' category on state map

The COVID-19 infection rate in the North End and surrounding neighborhoods increased 3.2 percent in one week according to the latest city statistics.

According to the latest data released by the Boston Public Health Commission (BPHC) on Friday the North End, as well as Beacon Hill, West End, Back Bay and Downtown the infection rate rose 3.2 percent since last week. The last increase week over week was 2.6 percent.

The BPHC data released last Friday showed the North End, Beacon Hill, West End, Back Bay and Downtown had an infection rate of 118.9 cases per 10,000 residents, up from 115.2 cases per 10,000 residents last Friday.

The number of confirmed cases in the area increased from 642 cases to 663 cases as of last Friday.

However, compared to other neighborhoods the North End, Beacon HillWest End, Back Bay and Downtown have the second lowest infection rates among residents second to only Fenway.

Beacon Hill is also still well below the city's average infection rate of 255 cases per 10,000 residents

Last week the BPHC reported that 23,980 North End, Beacon

Hill, West End, Back Bay and Downtown residents were tested for COVID-19 and the data shows that 1.5 percent of those tested were COVID positive. This was an increase of 25 percent from the 1.2 percent testing positive as reported last Friday. The citywide average was 3.9 percent.

Overall since the pandemic began 2.8 percent of North End, Beacon HillWest End, Back Bay and Downtown residents were found to be COVID positive.

The statistics released by the BPHC as part of its weekly COVID19 report breaks down the number of cases and infection rates in each neighborhood. It also breaks down the number of cases by age, gender and race.

Citywide positive cases of coronavirus rose by 0.3 percent last week from 17,649 cases to 17,712 confirmed cases. So far 14,857 Boston residents have fully recovered from the virus and the total number of fatalities in the city remained at 764.

During his daily press briefing on the virus Friday, Walsh said Boston had entered the "red" category on the state map on Wednesday, September 30.

"That means Boston is seeing eight or more daily cases per 100,000 population," said Walsh. He said this move was expected, but to note that this map is based on one metric--raw number of cases per day.

"We're also looking at the positive test rate and the hospital data and trends over time," he said. "Everyone must focus on what we can do to keep the activity down, and that is part of living with the virus. While the City is bringing resources and information to where it's needed, we also need everyone's help. That especially includes our young adults, among
